

# NWCCD Compliance Report

## CREDITS, PROGRAM LENGTH AND TUITION

As stated in Series 6010 of the College Policy and Procedures Handbook (<http://www.sheridan.edu/president/6000.nwc.pdf>), page 10) the college is authorized to award Associate of Arts (AA), Associate of Fine Arts (AFA), Associate of Science (AS), and Associate of Applied Science (AAS) degrees, each with established and published requirements. Degree requirements include General Education courses intended to provide the student a common core of knowledge appropriate to the degree level.

All Associate degrees require a minimum of 64 credit hours; 40 credits of General Education courses are required for an AS degree, 48 for an AA degree and 24 for an AFA degree. Degree and program requirements are maintained for public viewing in the College catalog at <http://catalog.sheridan.edu/>. These credit hour requirements are similar to those of the other six community colleges in Wyoming and meet the standards of the HLC Criteria for Accreditation.

NWCCD has nine categories of General Education courses – Writing, Math & Quantitative Reasoning, Science, Cultural Context (Humanities, Visual & Performing Arts, Social & Behavioral Science), US & WY Constitutions, Global Diversity, Communication, Health & Wellness, and Foreign Language. In addition to General Education requirements, specific program requirements provide a foundation of knowledge and skills more specific to the program of study to prepare students for transfer to a Baccalaureate program or for entry into the workforce.

NWCCD is also authorized to award Certificates of Completion to students demonstrating both knowledge and skills necessary for job-related functions in order to be successful in entry-level positions within a job category. While there is no minimum credit hour requirement, NWCCD's Certificates generally require two semesters of study, have at least 30 credit hours, and often lead into AAS programs. In a few instances a Certificate is available with fewer credit hours. These shorter programs supplement other programs, as is the case with the Athletic Coaching and Music Technician certificates, or meet a specific skill level for job placement, such as Early Childhood Education, Biotechnology, Carpentry, and Massage Therapy.

Wyoming community colleges and the University of Wyoming have a common course numbering system for transfer courses and some technical courses, and the University maintains a Transfer Guide. The community colleges must submit syllabi to the University for courses to be placed in the transfer guide and thereby approved for transfer to the University. As such, NWCCD faculty ensure that courses and programs align with the University for smooth transition and contain equal rigor. Each course is identified with an instructional method and a minimum number of classroom/lab minutes per credit hour awarded. Tuition is established by the Wyoming Community College Commission for all Wyoming community colleges. The Commission reviews tuition regularly and compares rates with other states in the region. The colleges have freedom in establishing program and/or course fees. NWCCD has established a program fee for just two programs – nursing and dental hygiene – because of the high costs associated with these programs. Still, the fee of \$250 per semester is conservative. Assessing other courses individually, faculty and administrators have identified those having high costs and have assessed moderate course fees. Courses having fees are primarily in science or technical departments.

## STUDENT COMPLAINTS

NWCCD has written procedures providing students avenues for communicating concerns to the administration. Students are encouraged to seek immediate resolution by visiting with a faculty member, student services administrator, Dean of Students or any other executive administrator, but also have options for making a formal complaint. Depending on the nature and severity of the complaint, a student may post a concern through the website, file an appeal, make a formal complaint, or file a grievance. Procedures are published in the College Policy and Procedure Handbook, in the Student Handbook and on the College website. Each process is discussed separately below.

Concern filed from website: The student portal web page, MyCollege (<https://mycollege.sheridan.edu/default.aspx>) under Student Feedback, provides an option for students to submit an issue or concern regarding Sheridan College or Gillette College. In many cases individuals submit a comment or question without identifying themselves. In other cases students will include a name and e-mail address with their submission and follow-up communication is made with the student. Once submitted, the message is delivered to the Dean of Students and her administrative assistant, Dean of Enrollment Services, and the Chair of the Student Issues and Concerns Committee. If one of the Deans cannot address a complaint directly, it is forwarded to the person most appropriate to handle it. In many cases, such as parking, a quick solution is not available but the complaint is acknowledged and relevant information is shared with the student.

**Appeals:** The student appeals process is used for students seeking a specific resolution such as having a bill reduced or removal from academic or financial aid suspension. Students have the right to take their case to the Dean of Students or file a grievance if they are unhappy with the decision of the Student Appeals Committee. However, that step is rarely taken by students once the rationale of the decision is communicated to the student. Information about the Student Appeals Committee is outlined under NWCCD Governance System in the College Policy and Procedures Handbook, Series 2005 and 2005.1 (<http://www.sheridan.edu/president/2000.nwc.pdf>, page 12). **Grievance:** A formal grievance process is in place to ensure that student rights are protected. A grievance is a dispute of policy and/or procedure with a member of the College community. The process is described in the Student Handbooks (Sheridan, page 15 and Gillette, page 16) or online at <http://www.sheridan.edu/offices/ir/sr.stuhand1011.pdf>, page 15. The Dean of Students is responsible for ensuring that student complaints are handled in an equitable manner. The grievance process is not intended to replace informal processes, but provides an additional avenue for dialog for students.

The grievance process establishes that a grieving student first meet with the Dean of Students in an effort to resolve the issue informally. If those efforts fail, the student may prepare a formal grievance and the grievance enters a formal hearing phase. A Grievance Committee is formed and is obligated to provide a prompt, fair, and equitable hearing, allowing the student and accused party to participate. The Committee submits written findings to the Dean of Students or designee and makes recommendations to resolve the grievance; the Dean of Students or designee makes the final decision. Hearing guidelines and strict timelines are provided in the grievance procedure to allow for fair and timely disposition of a complaint. Only three student grievances have been filed in the past three years and each was resolved informally.

## **TRANSFER POLICIES**

NWCCD transfer policies are described in our online catalog, located under General Information. ([http://catalog.sheridan.edu/content.php?catoid=5&navoid=112#Transfer\\_Policies](http://catalog.sheridan.edu/content.php?catoid=5&navoid=112#Transfer_Policies)). Applicants are asked to submit official transcripts and the evaluation process is further explained during the initial advising session. Many incoming students feel most comfortable contacting the Records Office directly to discuss transfer of coursework. Records Office personnel explain the process and personally walk through the steps if there is any confusion. In cases where a course is not initially equated to a NWCCD, the Associate Registrar will work with the student in locating more information about the course and working with academic departments in further evaluation of course outcomes.

## **VERIFICATION OF STUDENT IDENTITY**

NWCCD uses Blackboard Academic Suite to deliver course content online. Event driven integration is employed to push courses and enrollments from Datatel to Blackboard. Students access course materials in Blackboard using their NWCCD MyCollege username and password. Traditional high stakes multiple choice exams are discouraged unless the instructor implements a proctoring solution. Our Distance Learning Course Development Guide 2010-2011 provides guidelines for proctoring

<http://www.sheridan.edu/distance/faculty.asp>) Ideas for appropriate proctors are provided on our distance learning website for students (<http://www.sheridan.edu/distance/testing.asp>) that includes, but is not limited to, professionals from other accredited post secondary institutions, clergy, and library professionals. Hours and contact information for our College testing centers is also provided.

We have investigated identity solutions such as Axiom, which verifies identity but does not verify that the work submitted by students is their own. Another solution we have begun to investigate is ProctorU. This online solution has proctors who verify student identity using Webcam technology. NWCCD has recently purchased Elluminate Live. This Web conferencing solution may have potential for our testing centers in Sheridan, Gillette, and Buffalo to use Webcams for identity verification and exam proctoring.

Through student account activation for access to electronic services within our institution (email, WebAdvisor, Blackboard, etc) we verify student identity by one of the following unique identifiers:

1. Social Security Number + Student Last Name
2. Student ID + Student Last Name

Within the next year we plan to expand this verification to include a unique PIN or identifying information that is not pre-determined by existing student information prior to their arrival at the institution (such as date of birth, SSN, etc). This unique identifier would be utilized for activation of their accounts. The method of delivery and process for execution of this unique identifier has yet to be determined.

## **TITLE IV PROGRAM and RELATED RESPONSIBILITIES**

### **General Program Responsibilities**

NWCCD continues to be in good standing within the Title IV program. The College has never had negative reviews that resulted in fines or monitoring by the US Department of Education. The College received reauthorization to participate in the Title IV Programs on 02/19/2009 from the Denver Team.

### **Financial Responsibility Requirements**

NWCCD has an annual audit of its financial statements, including a determination of major programs in accordance with OMB Circular A-133. The audit includes internal control related to the major programs and an opinion on compliance with laws, regulations, and the provisions of contracts or grant agreements that could have a direct and material effect on each major program.

NWCCD files the electronic SF-SAC annually with the Federal Audit Clearinghouse and electronically submits its annual audit to the US Department of Education using the eZ-Audit system. The most recent 6 years of A-133 compliance audit contained no findings.

NWCCD calculates its composite financial ratios annually using its audited financial statements. The CFO reviews these ratios on an annual basis and presents an analysis to senior leadership on at least a biennial basis. These ratios are submitted to the Higher Learning Commission on an annual basis as part of the annual institution data update, including historical information back to fiscal year 2003. The College has a benchmark of at least 3.0 for its CFI.

### Student Loan Default Rates

Default rates for NWCCD for the past five years are shown below. The Department of Education has not reviewed or made negative findings related to our default rates. The National Cohort Rate is provided by the Department of Education and represents all Title IV institutions.

NWCCD rates have increased in recent years, following a national trend (Inside Higher Ed, 9/14/10 <http://www.insidehighered.com/news/2010/09/14/default> ). While the rate for NWCCD is higher than the national default rate for all institutions, our rate is only slightly higher than the rate for two-year institutions. A prolonged slump in the economy is a contributing factor, making it more difficult for students to stay in school or to meet financial obligations following graduation. The College educates its borrowing students on the importance of repayment and is proactive in its default management plan, which includes the following:

- Letters are sent to our students who are delinquent, encouraging them to contact their lenders to rehabilitate their delinquent loans.
- Loan counseling is required for all student borrowers.
- All First-time student borrowers are required to wait thirty days before receiving any loan funds. If the student is not maintaining standards of progress, the student is not entitled to the loan and the funds are returned to the lender.
- Loan exit counseling material is sent to all students who graduate or are no longer attending NWCCD.

### Campus Crime Information and Related Disclosure of Consumer Information

NWCCD maintains a Student Right-to-Know webpage to provide information to the public related to campus safety, graduation and transfer rates, student privacy, equity in athletics, financial aid policies, accreditation, and student rights and responsibilities. (<http://www.sheridan.edu/srtk>)

The Department of Education has made no negative findings related to our disclosures.

### **Satisfactory Academic Progress and Attendance Policies**

In order to stay in good standing for financial aid, full-time students must successfully complete at least 12 credit hours per semester or 68% of credits attempted, whichever is greater. Three-quarter time students must complete 9 credits and half-time students must complete at least 6 credits. Further, students must maintain a minimum cumulative GPA as follows: 1.6 GPA for the first 29 credits, 1.8 GPA for up to 44 credits, and 2.0 GPA thereafter. These requirements are consistent with federal regulations. Any student failing to meet the standards of satisfactory academic progress receives a letter from the Financial Aid Office explaining the loss of eligibility to participate in Title IV programs.

Information on Satisfactory Academic Progress is provided to students in person during their initial financial aid counseling meeting with Financial Aid personnel. Written information is available in four locations. First, on page 3 of the Financial Aid Policies document posted on the Financial Aid web page of the College website (<http://www.sheridan.edu/sc/financialaid/policies.aspx>). As part of the process, students must submit progress reports that are available at <http://www.sheridan.edu/sc/financialAid>. Second, in the Student Handbooks (Sheridan, page 12 and Gillette, page 14). #### **CLASS ABSENCE**

##### **Attendance Policies**

Each instructor or department shall include a copy of his/her attendance policies in each course syllabus and distribute it to all students in his/her classes at the beginning of each course. Adopted attendance policies shall be announced to and clearly understood by the classes affected. The District recognizes regular class attendance on the part of the student as a major contributor to student success and expects students to attend class regularly.

##### **Authorized Absence**

Although authorized class absences will not affect a student's course grade, a student is entitled and obligated to make up any/all work missed. Authorized absences are defined as:

Medical reasons;  
Personal tragedy, i.e., death, illness or accident in the family;  
Jury Duty.

#### Anticipated Absences

All anticipated absences incurred in representing the District in athletics, field trips, or other official capacities will be reported by the activity sponsor/coach to the instructors concerned in advance of the class meeting to be missed.

### **Contractual Relationships**

The College has a strategic alliance agreement, originally signed in 2003, with Career Step, LLC to provide online course access for the College's Medical Transcription Certificate of Completion Program. The content of this program is delivered using a predominantly online model with content experts located within Career Step. NWCCD has a program coordinator on-site who also functions as an advisor and faculty course facilitator to assist students in navigating the program, and linking students to resources to assist their learning as necessary. In addition, NWCCD offers a face-to-face class in medical terminology that serves this program as well as others.

NWCCD's Nursing Program is approved by the Wyoming State Board of Nursing and accredited by the National League for Nursing Accrediting Commission. The Dental Hygiene Program is accredited by the Commission on Dental Accreditation. Rigorous review of each program is completed at regular intervals to ensure compliance. Accreditation was reaffirmed for the Dental Hygiene Program in 2010. The Nursing Program had its accreditation reaffirmed in 2003 and will have its next visit in Spring 2011. In 2005, Northern Wyoming Community College District became one of roughly 100 regional colleges to adopt an alternative pilot accreditation program called "Academic Quality Improvement" or AQIP. Typically, the accreditation process happens once every ten years. In contrast, colleges that have chosen to go the AQIP route have accreditation "checkups" every seven.




